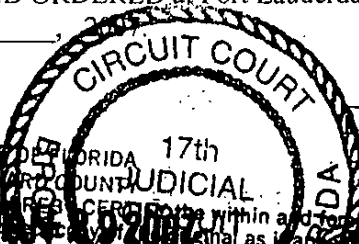
FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE
