Dear Ms Cushing,

I want thank you for the help you offered yesterday and sincerely hope to resolve this new corporation name issue as fast as practical.

As I stated, Industrial Technical Services, Inc. using David King of Orange Park Florida as attorney and Registered Agent, started the original name for me in 1994 with me as President (see attached).

Industrial Technical Services, LLC was later set up in 2004 as a Nevada Corporation and later domesticated in the State of Florida showing a 7401 SW 16th St, Plantation, Florida 33317 address where I am listed President and one of the Managing Members (again same people).

As I stated over the phone we have a \$100 million dollar FEMA contract and the frequency that the US Government normally audits their disaster contracts is causing disruption for the Industrial side of the company.

Our attorney Steve J. Polhemus has attempted to on-line set up Industrial Technical Services of Florida, Inc. and received Articles of incorporation that was shot down by email the next day because it is too close to our other (2) company names. I can have this same name and this will be over in about (15) with a phone call with another Nevada Corporation but we don't want to do that. We want it to be a Florida Corporation with Steve as our registered agent using Industrial Technical Services of Florida, Inc.
