ARTICLES OF INCORPORATION OF MUTIARA DECO, INC.

The undersigned incorporator, TIMOTHY H. GIBSON, an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is as follows:

MUTTARA DECO, INC.

This corporation is referred to in these articles of incorporation as the "Corporation."

ARTICLE 11 - PRINCIPAL OFFICE

The initial address of the principal office of the Corporation is 2200 Grundy Street, Pensacola, Florida 32507.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

to the proposed sale to a third person. The restrictions contained in this Article VI may be modified by a separate written agreement between the Corporation and the shareholder receiving shares in the initial issuance of stock of the Corporation.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT
