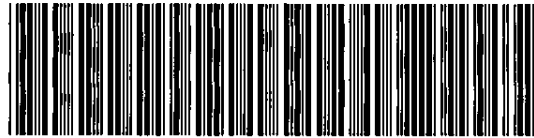

ARTICLES OF INCORPORATION

OF

COLOMBIAN AIR FORCE PURCHASING AGENCY INC.

ARTICLE I - NAME

The name of this corporation is: **COLOMBIAN AIR FORCE PURCHASING AGENCY INC.**

ARTICLE II - DURATION

This corporation is to have perpetual existence commencing January 15, 2007

ARTICLE III - PURPOSE

This corporation is organized for the purpose of contracting the acquisitions required by the Military Forces of Colombia in order to accomplish its mission, as well as supply information about offers of assets and services overseas. This corporation will not sell any merchandise or services, but rather will export to the Military Forces of Colombia their requisitioned goods in a procurement capacity.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock. The whole or any part of the capital stock of this corporation shall be payable in lawful money of the United States of America or property, labor or services at a valuation to be fixed by the Director.


