ARTICLES OF INCORPORATION OF

DAVIS STREET INVESTORS, INC.

The undersigned Subscriber, a natural person competent to contract, desires to form a Corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is DAVIS STREET INVESTORS, INC., and the principal office and address is: 1756 UNIVERSITY BLVD S.

JACKSONVILLE, FL 32216.

ARTICLE II. NATURE OF BUSINESS
