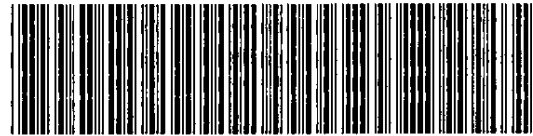

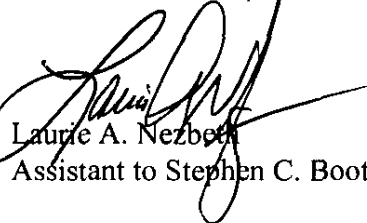

2. The foregoing Amendment was adopted by the shareholders of this Corporation on April 2, 2011, by unanimous vote.

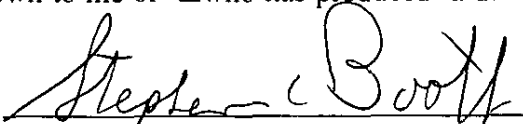

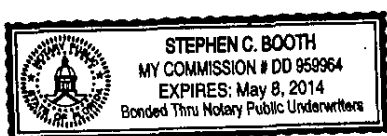

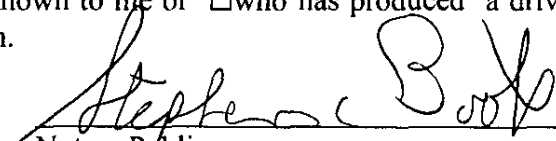
