

ARTICLES OF INCORPORATION

OF

ROADWAY WORKER SERVICES, INC.



ARTICLE I - NAME

The name of the corporation shall be ROADWAY WORKER SERVICES, INC.

ARTICLE II - OFFICE

The principal office of this corporation shall be situated at <u>3202 SAWGRASS VILLAGE CIR</u>, <u>PONTE VEDRA BEACH</u>, <u>FL 32082</u> and said corporation shall have the rights and privileges of business in such states of the United States and foreign countries whenever the Board of Directors may from time to time order and establish.

ARTICLE III - REGISTERED AGENT

ARTICLE IV - NATURE OF BUSINESS

The nature of the business and the purposes to the transacted are to engage in and to have unlimited power to do any lawful act concerning any of all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Law.

ARTICLE V - CAPITAL STOCK
