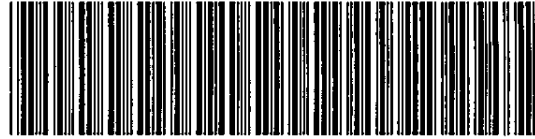

**ARTICLES OF INCORPORATION  
of  
AMERICAN DISCOUNT WINDOW TREATMENTS, INC.**

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of Florida.

**ARTICLE I – Name**

The name of the corporation is: American Discount Window Treatments, Inc.

**ARTICLE II – Commencement**

The corporation shall commence its corporate existence on the date a corporate charter is granted by the state of Florida. The corporation shall exist perpetually.

**ARTICLE III - General Purpose**

The purpose for which this corporation has been formed is to engage in and transact any and all lawful business permitted under the laws of Florida and the United States.

**ARTICLE IV – Capital Stock**

The maximum number of shares of stock that the corporation is authorized to issue is One Thousand (1,000) Shares of common stock with a par value of One Dollar (\$1.00) per share. The consideration actually payable for each share of stock shall be set by the Board of Directors. Common stock of the corporation shall be issued as “small business corporation” stock in accordance with a plan under the provisions of Section 1244 of the

Internal Revenue Code of 1954, as amended. The initial capital for the corporation shall be One Thousand Dollars (\$1,000.00).

**ARTICLE V – Place of Business and Registered Agent**

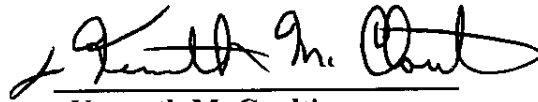
**ARTICLE VI – Board of Directors**

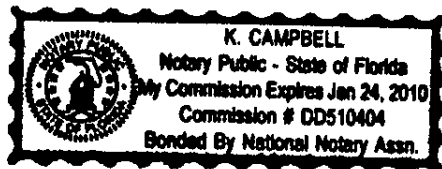

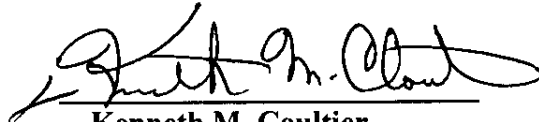
