ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF KNOB HILL GROUP, INC.

KNOB HILL GROUP, INC., a corporation organized and existing under the laws of the State of Florida, under certificate number P07000009278, filed in the office of the Secretary of State on January 22, 2007, hereby certifies as follows:

1. The directors and shareholders considered amending the Articles of Incorporation so as to recapitalize the corporate structure by changing the authorized number of shares of stock to One Hundred Thousand (100,000), and to provide for a par value of \$0.01. After discussion, it was

RESOLVED, that the Articles of Incorporation of KNOB HIGH GROUP, INC. be amended so as to increase the maximum number of shares of stock authorized to One Hundred Thousand (100,000) and to set the par value to \$0.01 per share, and that Articles IV shall be amended to read its entirety as follows:

"ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Hundred Thousand (100,000) shares of common stock having a par value of One Cent (\$0.01) per share. Ten Thousand (10,000) of said shares shall be designated and known as voting common stock and Ninety Thousand (90,000) of said shares shall be designated and known as nonvoting common stock. Except for voting rights, all shares of common stock shall be subject to the same rights and shall be in equal in all other respects."

2. These Articles of Amendment were approved by all of the director(s) of the corporation and by all of the shareholder(s) by joint written action dated MRCHY, 2008.
