ARTICLES OF INCORPORATION OF NATALIE J LAMNECK, DVM, PA.

ARTICLE I

Name. The name of this corporation is NATALIE J LAMNECK, DVM, PA.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting a veterinary business.

ARTICLE IV
