The undersigned, acting as incorporator of 4 CORNERS CAR WASH, INC., adopts the following Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

COMMENCEMENT AND TERM OF EXISTENCE**

The existence of the corporation will commence at 12:01 on the date of filing these Articles of Incorporation and shall continue perpetually.

NATURE OF BUSINESS**

The purpose of the corporation is to engage in the following business activities:

1. Engage in the activities of a retail car wash business, both self-service and automatic touchless, and related services and products, together with other and ancillary businesses.
2. Any other lawful activity permitted under the laws of the state of Florida.

ARTICLE V
CAPITAL STOCK

The maximum number of shares that the corporation is authorized to have outstanding at any one time is 1,000,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT


