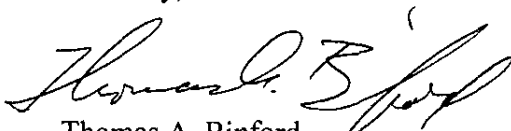

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME.

The name of this Corporation is JACKIE CAROL CARTER-PARLANTE, P. A.

ARTICLE II. DURATION.

This Corporation shall have perpetual existence.

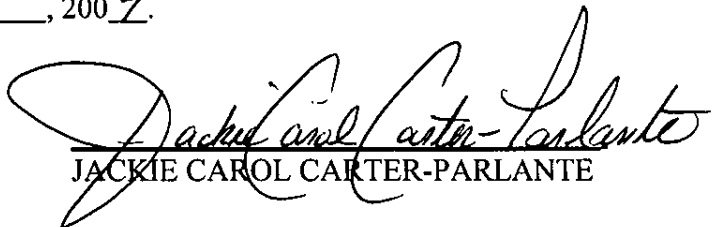

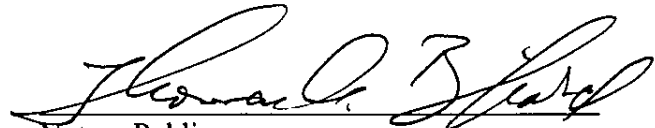
