

# Articles of Incorporation of

Robert Blanchfield, P.A.

The undersigned hereby makes, subscribes, acknowledges and file with the Secretary of State of Florida these Articles of Incorporation in compliance with Chapter 607 and/or Chapter 621, Florida Statutes, for the purpose of forming a professional association (the "Corporation") for profit in accordance with the laws of the State of Florida.

#### Article I. - Name

The name of the Corporation shall be the Robert Blanchfield, P.A.

# Article II – Existence of Corporation

This corporation shall begin existence on the date of filing these Articles with the Secretary of State, Department of Corporations for the State of Florida and shall have perpetual existence.

# Article III – Principal Office

The street address and mailing address of the corporation's principal office is 191 White Oak Circle, Maitland, Florida 32751. The corporation may change its principal office by filing with the Department of State of the State of Florida a statement complying with Section 607.0502 Florida Statutes.

# Article IV - Purpose

The corporation may engage in the practice of law and the transaction of any and all lawful business for which corporation may be incorporated under the laws of the State of Florida.

#### Article V - General Powers

The corporation shall have power:

- (a) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or facsimile thereof, to be impressed, affixed, or in any other many reproduced.
- (b) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.
- (c) To sell, convey, mortgage, pledge create a security interest in, lease, exchange, transfer and to otherwise dispose of all or any part of its property and assets.
- (d) To lend money to, and use its credit to assist, its officers and employees in accordance with Sec. 607.0833, Fla. Stat.
- (e) To purchase, take, receive, subscribe for, or otherwise own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships or individuals, or direct or indirect obligations of the United States or any other government, state, territory, government district, or municipality, or of an instrumentality thereof.
- (f) To makes contracts and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, or other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.
- (g) To lend money for it corporate purposes, invest and reinvest it funds, and to take and hold real and personal property as the security for payment of funds so loaned or invested.
- (h) To conduct business, carry on its operations, and have offices and exercise the power granted by this act within or without this state.
- (i) To elect or appoint officers or agents of the corporation and define their duties and fix their compensation.
- (j) To make and alter bylaws, not inconsistent with its Articles of Incorporation or with the laws of the State of Florida, for the administration and regulation of the affairs of the corporation.
- (k) To make donations for the public welfare or for charitable, scientific or educational purposes.
- (1) To pay pensions and carry out pension plans, profit sharing plans, stock bonus plans, retirement plans, benefit plans, and other incentive compensation plans for any or all of its directors, officers, and employees.

- (m) To provide insurance for its benefit on the life of any of its directors, officers, or employees, or on the life of any shareholder for the purpose of acquiring, at death, shares of its stock owned by the shareholder or by the spouse or children of the shareholder.
- (n) To be a promoter, incorporator, general partner, limited partner, member, associate or manager or any corporation, partnership, limited partnership, joint venture, trust or other enterprise.
- (o) To have and exercise all powers necessary or convenient to affect its purpose.

#### Article VI - Shares

- (a) The total number of shares of capital stock authorized to be issued by the corporation shall be one hundred shares having a par value of one dollar per share. Each of these shares of stock shall entitle the holder thereof to one vote at any meeting of the stockholders. All or any part of this capital stock may be paid for in cash, in property or in labor or services actually performed for the corporation and valued at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be non assessable.
- (b) The election of directors of this corporation there shall be no cumulative voting of the stock to vote at such election.

#### Article VII - Initial Officers/Directors
