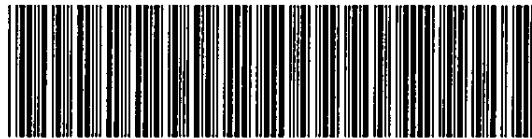

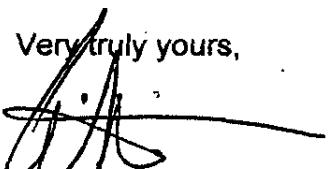

ARTICLE I

The name of this corporation is WILLIAM H WAITE INC. Whose principal address is 504

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in
marine staffing to the profession, a business permitted under the laws of the State of
