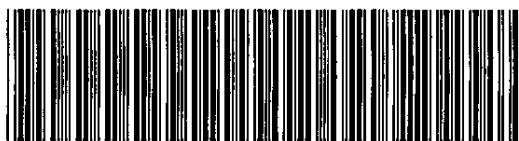

ARTICLE 1 - NAME AND ADDRESS
