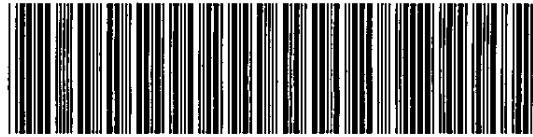

The undersigned, acting as incorporator of **WELLINGTON'S ENTERPRISE, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is **WELLINGTON'S ENTERPRISE, INC.**

**ARTICLE II. ADDRESS**

The mailing address of the corporation is 4440 N.W. 168<sup>TH</sup> TERRACE, CAROL CITY, FLORIDA 33055.

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence upon the filing of these articles of incorporation.

**ARTICLE IV. PURPOSE**

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

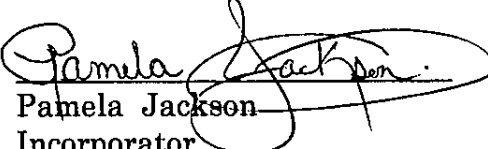
## ARTICLE VIII. BYLAWS

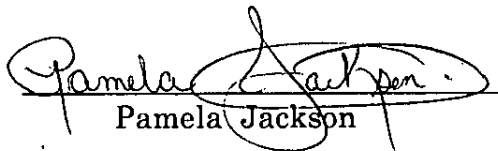
