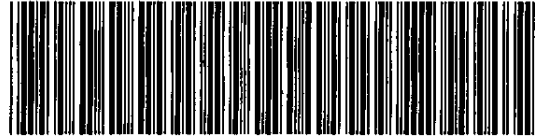

This corporation is organized for the purpose of transacting any and all lawful business in the United States.


ARTICLE IV
