**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
HAMMOND AIR CONDITIONING INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendments to its Articles of Incorporation:

The new corporate name is: HAMMOND AIR CONDITIONING, INC.

Article IV shall be changed to read:

ARTICLE IV- SHARES

The aggregate number of shares which the corporation is authorized to issue is Ten Thousand (10,000) shares of common stock. Such shares shall be of a single class and shall have a par value of \$.01/100 per share.


A new Article VIII shall be added:

ARTICLE VIII – INDEMNIFICATION

Unless expressly prohibited by Florida law, the Corporation shall indemnify and hold harmless any directors from and against any and all claims and demands against such person whatsoever which relate in any manner to or arise from the activities of the Corporation or assets owned by the Corporation.

These amendments were approved by the shareholders. The number of votes cast for the amendments by the shareholders was sufficient for approval.

These amendments were adopted on March 12, 2007 and the effective date of these amendments is March 12, 2007.
