ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Chinese Ceramic Tile Imports, Inc. (the "Corporation"). Its principal office address and business mailing address is: 524 S. Andrews Ave, 1st Floor, Ft. Lauderdale, FL 33301.

ARTICLE II - DURATION

The Corporation shall commence its existence on filing of these Articles of Incorporation. The Corporation's existence shall be perpetual unless the Corporation is dissolved earlier as provided in these Articles of Organization or in the regulations.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000,000 shares of common stock, having a par value of \$.01 per share.

**ARTICLE V - INITIAL
REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this Corporation shall be 350 East Las Olas Boulevard, Suite 1700, Ft. Lauderdale, FL 33301, and the initial registered agent of this Corporation at such office shall be Charles Tatelbaum, who upon accepting this designation agrees to comply with the provisions of Chapters 48 and 607, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of one member. The number of directors may be increased or decreased from time to time by vote of the Board of Directors, but in no case shall the number of directors be less than one. The initial Board of Directors shall be selected as provided in the Bylaws.
