**ARTICLES OF AMENDMENT
TO
THE ARTICLES OF INCORPORATION
OF
CHINESE CERAMIC TILE IMPORTS, INC.**

1. The name of this corporation is Chinese Ceramic Tile Imports, Inc., a Florida corporation (the "Corporation"), whose principal office address is 524 S. Andrews Ave, 1st Floor, Ft. Lauderdale, Florida, 33301.

2. Article I, of the Articles of Incorporation of Chinese Ceramic Tile Imports, Inc. is hereby deleted in its entirety and replaced as follows:

"ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this corporation is China Ceramic Tile Imports, Inc., a Florida corporation (the "Corporation"), whose principal office address is 524 S. Andrews Ave, 1st Floor, Ft. Lauderdale, Florida, 33301."

3. The foregoing amendment was adopted by Charles Tatelbaum, the sole incorporator of the Corporation on February 26, 2007.

The sole incorporator is authorized to adopt this amendment under Florida Statutes, Section 607.1005, because as of the date hereof, the Corporation has not (i) issued any shares; (ii) elected or appointed any officers or directors; and, (iii) has not had an organizational meeting.
