The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I

The name of the corporation is "Wakulla Watershed Coalition, Inc." The principal place of business is: 223 Iroquois Road, Crawfordville, Florida 32327.

ARTICLE II

This corporation shall have perpetual existence.
