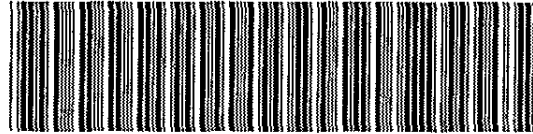

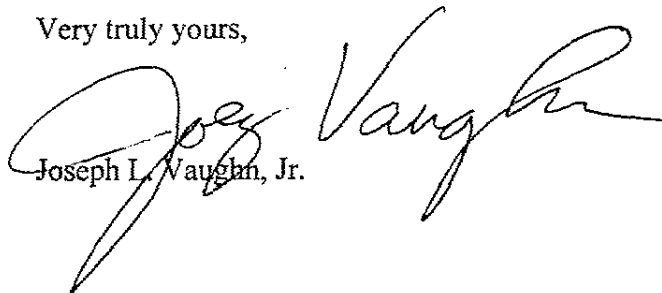

In compliance with Chapter 607, Florida Statutes, the undersigned acting as Incorporator does hereby adopt and file the following Articles of Incorporation for the purpose of organizing a corporation in the State of Florida.

ARTICLE I
NAME

The name of the Corporation is **CLAYTON BREWER & ASSOCIATES, INC.**, (hereinafter the "Corporation").

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The street address and the mailing address of the initial principal office of the Corporation is 1144 Eagle Point Drive, St. Augustine, Florida 32092.

ARTICLE III
DURATION

The existence of the Corporation shall begin on the date of filing with the Department of State, Division of Corporations, State of Florida, and the term of duration of the Corporation shall be perpetual.

ARTICLE IV

INITIAL REGISTERED OFFICE AND AGENT

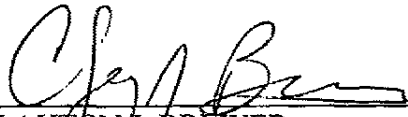
