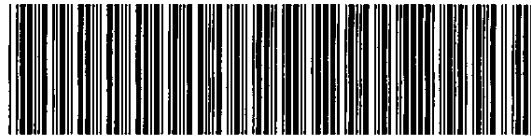

NAME

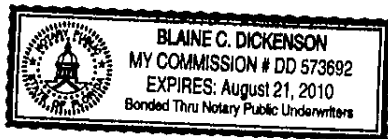


