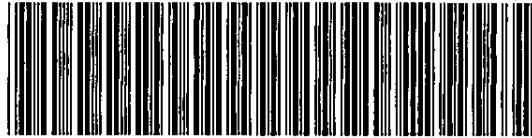

The undersigned a citizen of the United States desiring to form a corporation for profit, does hereby certify:

ARTICLE I - NAME

The name of the corporation is:

DONZ, INC.

Effective Date *Feb. 01, 2007*

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 950 Carstairs Court,
Tarpon Springs, Florida, 34688.

ARTICLE III - EFFECTIVE DATE

The effective date of the corporation shall be February 1, 2007.

ARTICLE IV - PURPOSE


The corporation reserves the right to amend or repeal any provision contained in




