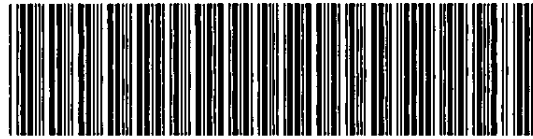

Article I: The name of the corporation is Revim Pharmaceutical, Inc.

Article II: The address of its principal and mailing office in the State of Florida is 13336 North Central Avenue, Tampa, FL 33612.

Article III: The nature of the business or purpose to be conducted or promoted is:

To engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida.

Article IV: The total number of shares of stock which the corporation shall have authorized to issue is One Million (1,000,000) and the par value of each of such shares is Ten Cents (\$.10) amounting in the aggregate to One Hundred Thousand Dollars (\$100,000.00).

Article V: The name, title and mailing address of each Director/Officer is as follows:

Article VI: The name of the registered agent is Robert A. Carr with a mailing address of 13336 North Central Avenue, Tampa, Florida 33612.

Article VII: The name of the incorporator is Robert A. Carr with a mailing address of 13336 North Central Avenue, Tampa, Florida 33612.

Article VIII: The corporation is to have perpetual existence.

Article IX: In furtherance and not in limitation of the powers conferred by statute, the board of directors is expressly authorized:

To make, alter or repeal the by-laws of the corporation.

To authorize and cause to be executed mortgages and liens upon the real and

personal property of the corporation.

To set apart out of any of the funds of the corporation available for dividends, a reserve or reserves for any proper purpose and to abolish any such reserve in the manner in which it was created.

By a majority of the whole board, to designate one or more committees, each committee to consist of two or more of the directors of the corporation. The board may designate one or more directors as alternate members of any committee, who may replace any absent or disqualified member at any meeting of the committee. Any such committee, to the extent provided in the resolution or in the by-laws of the corporation, shall have and may exercise the powers of the board of directors in the management of the business and affairs of the corporation, and may authorize the seal of the corporation to be affixed to all papers which may require it; provided, however, the by-laws may provide that in the absence or disqualification of any member of such committee or committees, the member or members thereof present at any meeting and not disqualified from voting, whether or not he or they constitute a quorum, may unanimously appoint another member of the board of directors to act at the meeting in the place of any such absent or disqualified member.


When and as authorized by the affirmative vote of the holders of a majority of the stock issued and outstanding having voting power given at a stockholders' meeting duly called upon such notice as is required by statute, or when authorized by the written consent of the holders of a majority of the voting stock issued and outstanding, to sell, lease or exchange all or substantially all of the property and assets of the corporation, including its good will and its corporate franchises, upon such terms and conditions and for such consideration, which may consist in whole or in part of money or property including shares of stock in, and/or other securities of, any other corporation or corporations, as its board of directors shall deem expedient and for the best interests of the corporation.

Article X: Meetings of stockholders may be held within or without the State of Florida, as the by-laws may provide. The books of the corporation may be kept (subject to any provisions contained in the statutes) outside the State of Florida at such place or places as may be designated from time to time by the board of directors or in the by-laws of the corporation. Elections of directors need not be by written ballot unless the by-laws of the corporation shall so provide.

Article XI: The corporation reserves the right to amend, alter, change or repeal any provision contained in this certificate of incorporation, in the manner now or hereafter prescribed by statute, and all rights conferred upon stockholders herein are granted subject to this reservation.


