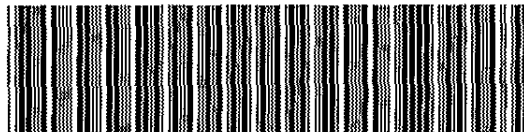

ARTICLE I

The name of this corporation is S&M Kenton, Inc.
