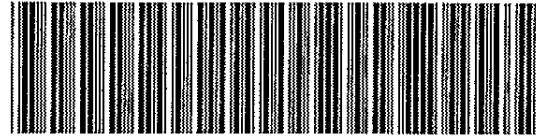

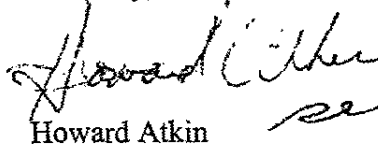

ARTICLES OF INCORPORATION

**OF

ARTICLE I - NAME

The name of the corporation is BOOT STRAP, INC..

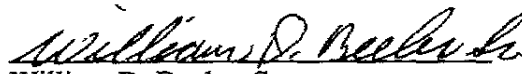
