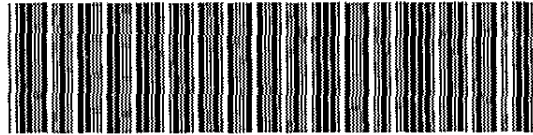

AMENDMENT


