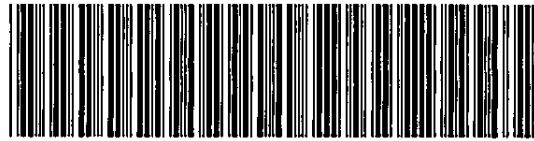

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation to be governed by the provisions set forth under the "Florida Business Corporation Act" Chapter 607, Florida Statutes.

ARTICLE I. NAME

The name of the Corporation shall be R.C. Hitchins Financial Services, Inc. The principal place of business of this Corporation shall be 325 South Olive Avenue, West Palm Beach, Florida 33401.

ARTICLE II. NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

This Corporation is authorized to issue 5,000,000 shares of OneTenth of One Cent (\$.001) par value common stock.

None of the shares of the corporation may be issued to anyone other than an individual duly licensed as a Certified Public Accountant in the State of Florida.

No shareholder of this Corporation shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of the stock, however, the shareholder may enter into agreements with the Corporation or with each other to control or restrict the transfer of stock and such agreements may take the form of options, rights of first refusal, buy and sell agreements or any other lawful form of agreement.

ARTICLE IV. ADDRESS

The street address of the initial registered office of the Corporation shall be 325 South Olive Avenue, West Palm Beach, Florida 33401, and the name of the initial registered agent of the Corporation at that address is Richard C. Hitchins.

ARTICLE V. TERM OF EXISTENCE

This Corporation shall have perpetual existence.
