## ARTICLES OF INCORPORATION OF ALISET, CORP.



The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

#### ARTICLE I.

#### NAME

The name of the Corporation shall be ALISET, CORP.

#### ARTICLE II.

#### PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 1453 NW 13 TER, Miami, Fl. 33125

#### ARTICLE III.

#### **PURPOSES**

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:

#### **INSPECTION OF BOOKS AND RECORDS**
