**Samuel B. Avraham, 4411 N. Bay Road, Miami Beach, FL 33139"**

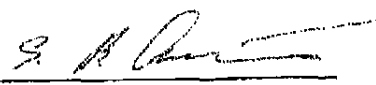
"6. The names, address and titles of the Directors/Officers is:
