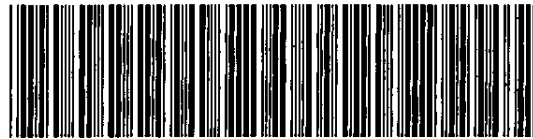



ARTICLES OF INCORPORATION
OF

ARTICLE I

Name of Corporation

The name of this corporation is MD LANDSCAPING SERVICES INC.

ARTICLE II

Purpose

Organized primarily as a provider of landscaping services, MD LANDSCAPING SERVICES INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.




