The undersigned, acting as the incorporator pursuant to Chapter 621 of the Florida Statutes, hereby forms a Corporation for profit under the laws of the State of Florida and adopts this document as the Articles of Incorporation for the Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation is Marc H. Sherman, O.D., P.A.

ARTICLE II - TERM OF EXISTENCE

This Corporation will commence its existence on the date of filing of these

Articles and will exist perpetually thereafter unless dissolved according to law.
