The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, herby forms a corporation under the laws of the State of Florida.

# ARTICLE I - NAME

The name of this corporation is BENCHMARK ROOFING OF WEST PASCO, INC.

#### ARTICLE II - PURPOSE OF BUSINESS

To the same extent as natural persons might or could do, the Corporation shall have the power:
