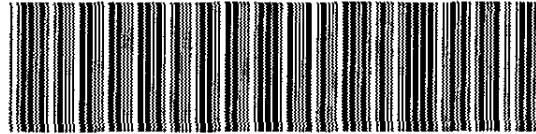

**ARTICLES OF INCORPORATION OF

A FLORIDA PROFESSIONAL SERVICE CORPORATION**

The undersigned person, acting as incorporator for the purpose of forming a professional service corporation under the laws of the State of Florida, executes the following Articles of Incorporation in compliance with Chapters 621 and 607, Florida Statutes.

**ARTICLE 1 – Name**

The name of the professional service corporation shall be: Monica Costa-Moreno, A.P., P.A.

**ARTICLE 2 – Commencement and Duration**




