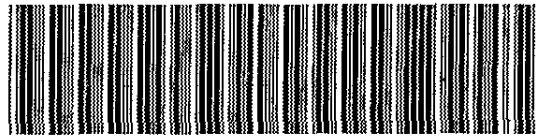

The initial officer of the corporation is Joseph Casanova, 618 S.W. 22nd Terrace, Cape Coral, Florida 33991 as President and Secretary.



