

ARTICLES OF INCORPORATION

OF

MERRITT LAW, P.A.

In compliance with and for the purpose of becoming a professional corporation for profit under the provisions of Chapter 621 of the laws of the State of Florida, and pursuant to the following articles of incorporation:

ARTICLE I.
