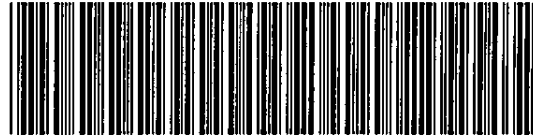

ARTICLES OF INCORPORATION

OF

EVERGLADES PRO., INC.

ARTICLE I

NAME

The name of this corporation is Everglades Pro., Inc.

DURATION

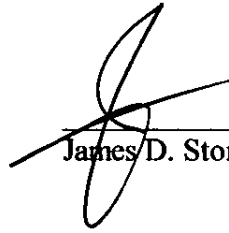
The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

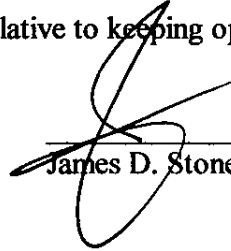
