ARTICLES OF INCORPORATION

OF

J.K. JOHNS ROOFING AND SHEET METAL, INC.

THE UNDERSIGNED incorporator hereby executes and acknowledges these Apples of Incorporation for the purposes of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE 1 - NAME

The name of the corporation is J.K. JOHNS ROOFING AND SHEET METAL, INC.

ARTICLE IL - COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date of subscription and acknowledgment of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - PURPOSE: ELECTION OF SUBCHAPTER S STATUS

The corporation is organized for the purpose of transacting any and all lawful business. The incorporators and shareholders elect that this shall be a Subchapter S corporation.

ARTICLE IV - STATED CAPITAL

The aggregate number of shares that the corporation shall have the authority to issue is 10,000 (Ten Thousand) shares of capital stock with the par value of \$1.00 per share. 100 (One Hundred) shares of the capital stock of the corporation shall be issued for cash or other property (tangible or intangible) or for labor or services actually performed for this corporation, at fair valuation to be fixed by the Board of Directors. The shares of the corporation are not to be divided into classes.

ARTICLE V - BOARD OF DIRECTORS

All corporation powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the Board of Directors. The corporation shall have two directors initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the by-laws of the corporation.

ARTICLE VI. INDEMNIFICATION

The corporation shall indemnify any present or former officer or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.

ARTICLE VII - BY-LAWS

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and sharcholders, but the Board of Directors may not alter, amend or repeal any bylaws adopted by the shareholders if the shareholders provide that the by-laws cannot be altered, amended or repealed by the Board of Directors.
