The undersigned incorporator, DIANE P. APPELYARD, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

**ARTICLE I - NAME**

The name of this corporation is CORE CONSULTING, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The address of the principal office of the corporation is 4400 Bayou Boulevard, Suite 34, Pensacola, Florida 32503.

**ARTICLE III - PURPOSE**
