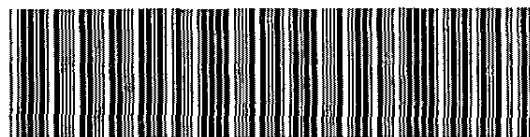

The initial officers and directors are as follows: Rory L. Clark President, and Director at 1005 ½ Massachusetts Avenue, Pensacola, FL 32505.

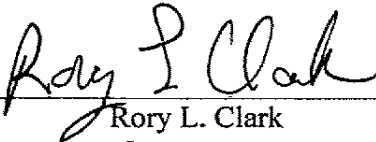

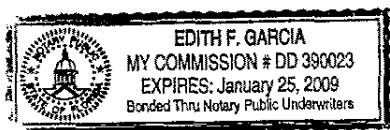
