ARTICLES OF INCORPORATION

OF

CANAM SOUTE ROOFING, INC.

## ARTICLE I- NAME:

The name of this corporation is CANAM SOUTH ROOFING, INC.

## ARTICLE IT- DURATION:

This corporation shall have perpetual existence commencing on the 12 th. day of February, 2007.

#### ARTYCLE XII-PURPOSE:

This corporation is organized for the purpose of conducting a rocaling business including renowing, resurfacing and sales of accessorics and consulting, and purchasing firm including all products related thereto including but not limited to necessary materials as well as appropriate software programs, and for the conduct of any and all other lawful business, and this corporation shall have all powers to effect its purpose.

#### ARTICLE IV- CAPITAL STOCK:

This corporation is authorized to issue one hundred (1,000) shares of One Dollar (\$1.00) par value common stock.

ARTICLE Y- RIGHTS OF SHARKS OF CAPITAL STOCK:

Section 1. Rights Upon Liquidation or Dissolution.

The assets of this corporation shall be payable to and distributed ratably among the holders of record of the common shares.

Section 2. Voting Rights.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be voted exclusively in the holders of the outstanding common shares.

### ARTICLE VI- PRESCRIVE RIGHTS:

Every shareholder, upon the sale for cash of any new stock of the corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional charcs) at the price which it is offered to others.

# ARTICLE VII - INITIAL PRGISTERED OFFICE AND AGENT:

The street address of this corporation is 2425 Howard Rd, Hallandale fl., 33009, and the name of the initial registered agent of this corporation at that address is Carol Latouche.

#### ARTICLE VIII - INTTIAL BOARD OF DIRECTORS;

This corporation shall have 1 director initially. names and addresses of the initial director of this corporation is Carol Latouche, 1281 Blvd. Raymond, Beauport, Quebec, B18 1KL;

# ARTICLE IX " INCORPORATOR:

The name and address of the person signing these Articles of Incorporation is: Carol 1261 Latouche, Blvd. Raymond, Basuport. Quebac.

# ARTICLE X - BYLANS:

The power to adopt, alter, amend or repeal the bylaws shall be vested in the Beard of Directors and the Shareholders.

## ARTICLE AT - CALLING SPECIAL MEETINGS:

Special meetings of Shareholders may be called by 50% of the holders of the outstanding common stock.

# ARTICLE XII - SHARRHOLDER OCORON AND VOTING:

Fifty percent (50%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a macting of the shareholders.

#### ARTICLE RITI - APPROVAL OF PHAREHOLDERS RECOIRED FOR MERGER:

The approval of the sharsholders of this corporation to any plan of morgor shall be required in every case, whether or not such approval is required by law. Said approval may be made at a meeting of the shareholders or in writing as provided by law.

#### ARTICLE RIV - RIGHTS OF SHAREHOLDERS TO DISSENT!

The shareholders of this corporation shall have the right to dissent from any corporate actions from which shareholders are entitled to dissent.

## ANTICLE TV - SEAREBOLUERS MEETING REQUIRED:

Any action of the shareholders of this corporation must be taken at a meeting of shareholders of this corporation, duly called as provided by law, unless written consent by holders of 75% of all issued and outstanding shares is obtained.

# ANTICLE TYL - MANAGEMENT OF CORPORATION BY SHAREHOLDERS:

All comporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the shareholders of this corporation until such time as the directors may elect officers.

## ARTICLE RVIE - POWERS:

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act, except this corporation shall not have the power to be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, joint venture, trust or other enterprise, unless approval is given by 2/3 of the holders of the outstanding common stock.

# ARTICLE MVILT - DISECTORS COMPENSATION:

The shareholders of this corporation shall have the exclusive authority to fix the compensation of directors of this corporation.

## ARTICLE XIX - NO REGIVAL OF DIRECTORS:

The shareholders of this comporation shall not be entitled to remove any director from office during his term, unless otherwise provided by the laws of the State of Florida and the Florida General Corporation Act.

# ARTICLE XX - MEETINGS BY CONFERENCE TELEPHONE:

Members of the Board of Directors may participate in meeting of the Board of Directors by means of conference telephone as provided by law.

### ARTICLE XXI - ACTION BY DIRECTORS MITHOUT A MEETING:

The directors of this comporation may take action by written consent, as provided by law.

#### ARTICLE EXIT - DIVIDENDS:

Dividends may be paid to shareholders from the operating surplus of the corporation or from capital in the form of a tax free Yelurn of capital as may be determined by the Board of Directors. Dividends payable in shares of any class of stock may be paid to the holders of shares of any other class in lieu of a cash dividend payment as may be determined by the Board of Directors.

#### ARTICLE EXTLI - INDEMNIFICATION:

The corporation shall indomnify any officer or director, or any former officer or director, to the full extent permitted by law.

## ARTICLE XXIV - FISCAL YEAR:

The end of the accounting year of this corporation shall be the end of the calendar year.

#### ARTICLE XXV - AMENDMENT:

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any rights conferred upon the shareholders is subject to this reservation. Any amendment to the Articles of Incorporation shall be by a vote of 2/3 of the outstanding shares of stock or by written consent of the holders of 2/3 of the outstanding shares of the common stock of the corporation.
