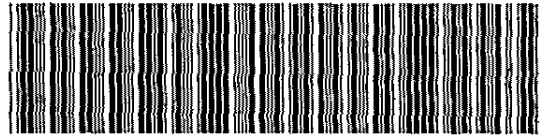

ARTICLES OF INCORPORATION
