**ARTICLES OF INCORPORATION  
OF

**ARTICLE I**

**CAPITAL STOCK**

The aggregate number of shares of stock authorized to be issued by this corporation shall be 7,500 shares of common stock, each with a par value of \$.001. **BY-LAWS**


