#### ARTICLE I, NAME OF CORPORATION:

The name of the Corporation shall be MVA AMERICA INC.

#### ARTICLE II, GENERAL NATURE OF THE BUSINESS:

The general nature of the business and the object and purpose to be transacted and cerried are: To conduct business not prohibited by the Laws of the United States and the State of Fiorida. #### ARTICLE III, CAPITAL STOCK:

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 100 shares at \$ 1.00 per share. 
