In compliance with Chapter 607 F.S. (Profit), the following are the Articles of Incorporation of Eugenio Company:

- ARTICLE I Name. The name of the corporation shall be Eugenio Company.
- ARTICLE II Principal Office. The principal place of business and the mailing address of the corporation is 6904 Manatee Avenue West, Suite 65B, Bradenton, Florida 34209.
