In compliance with Chapter 607 F.S. (Profit), the following are the Articles of Incorporation of Eugenio Company:

- ARTICLE I Name. The name of the corporation shall be Eugenio Company.
- ARTICLE II Principal Office. The principal place of business and the mailing address of the corporation is 6904 Manatee Avenue West, Suite 65B, Bradenton, Florida 34209.
- ARTICLE III Purpose. The purpose for which the corporation is organized is to engage in any activity within the purposes for which corporations may be formed under the Business Corporation Act of Florida.
