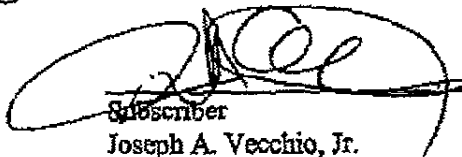
## ARTICLE X - INDEMNIFICATION
