ARTICLES OF INCORPORATION

OF

SIMPLY CHEESECAKES, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE Name

The name of the corporation is: SIMPLY CHEESECAKES, INC.

ARTICLE TWO Principal Office

The street address of the initial principal office of the corporation is 5425 Rushmore Drive, Panama City, FL 32404.

ARTICLE THREE **Corporate Duration**

The duration of the corporation is perpetual.

ARTICLE FOUR **Purpose or Purposes**

The general purposes for which the corporation is organized are:

- 1. To conduct and operate a food service business.
- 2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FIVE Capitalization

The aggregate number of shares which the corporation is authorized to issue is 1,000. Such shares shall be of a single class, and shall have a par value of One Cent (\$0.01) per share.

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
