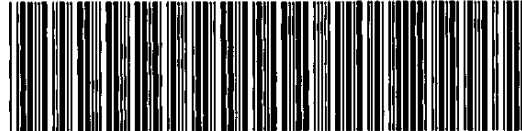

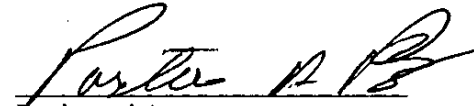

**Article XIII – Amendment**

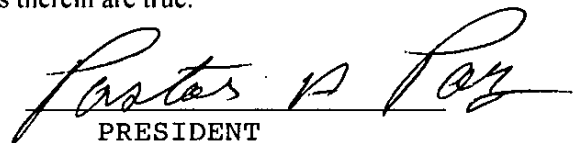

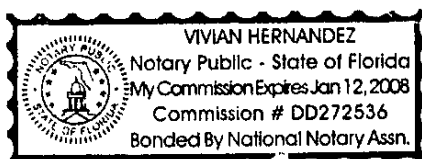
